

COVID-19 Vaccination Report - Two Rivers Health District : Dec 15, 2020 - Aug 23, 2021

The graphs depict the current status of COVID-19 vaccination in Two Rivers Public Health District (TRPHD) as of Aug 23, 2021. This includes residents of **Buffalo**, **Dawson**, **Franklin**, **Gosper**, **Harlan**, **Kearney & Phelps** counties (96.986). Of these, 81,216 persons are currently eligible for the vaccine (aged 12 years or more)¹. Currently, we are reporting vaccinated numbers by <u>total population</u> in TRPHD, to have a better sense of the overall vaccine coverage in the community.

- Graphs 1 & 2 show relative number of **residents of each county** who have received one or two shots of the vaccine from **Dec 15, 2020 Aug 23, 2021.**
 - Graph 1 shows the number of TRPHD residents (all ages) per county, and orders
 counties by decreasing percentage of persons who received one or two doses of the
 vaccine.
 - Graphs 2-6 shows the number of persons aged 0-17, 18-29, 30-49, 50-64 & 65+ years in TRPHD, and orders each county by decreasing percentage of persons who received one dose and those fully vaccinated.
- Graph 7 tracks the daily number of people fully vaccinated in TRPHD by county from 4 Jan
 23 Aug 2021. Also shown is the cumulative number of fully vaccinated persons in TRPHD.
- The table describes the proportion of persons vaccinated by age, further desegregated by county of residence.


- 1. As of Aug 23, 2021, 41% of TRPHD's total population and 49% of all eligible residents (12 years and over) are fully vaccinated.
- 2. Weekly vaccination rates across the health district continue to pick up after a relative drop in uptake from May-July. Almost 2500 TRPHD residents had their first dose of vaccination August. Almost 1500 residents received their second dose in August.
- 3. As of August 23, over 50% of Kearney city, 48% of Lexington and 47% of Holdrege residents have received at least one dose of vaccine. COVID cases have risen across TRPHD, new cases increased by 67% across the district this week..
- 4. There is fairly robust evidence that two doses of the mRNA vaccine is highly effective in protecting people from newer COVID variants (like delta, gamma variants). TRPHD <u>strongly</u> urges all residents to avail of the full vaccination schedule (1 or 2 doses as indicated) through the health department or their clinic provider.
- 5. Two Rivers Health Department has scheduled mobile vaccination clinics at multiple sites across the seven counties to distribute vaccines and to focus on areas of potential shortfall. Those eligible for the vaccine are advised to refer to the vaccination clinic schedule at www.trphd.org and book their appointment.

- Overall, 51.9% of the adult (18+) population in Two Rivers Health District is now fully vaccinated; 54.1% have received at least one dose of COVID vaccine.



- Overall, 28.7% of those aged 18-29 years in Two Rivers Health District are now fully vaccinated; 32.3% have received at least one dose of COVID vaccine.




- Vaccine formulations by Pfizer and Moderna (2 doses) and Johnson & Johnson (single dose) are calculated accordingly
- Each county is depicted by a colored circle, and the relative position of each corresponds to the proportion vaccinated. Actual numbers (count) are included in parenthesis.
- Data is described from **Dec 15, 2020 Aug 23, 2021**. All residents of the seven counties **aged 30-49** years are included.
- Overall, 43.3% of those aged 30-49 years in Two Rivers Health District are now fully vaccinated; 46.8% have received at least one dose of COVID vaccine.






- Vaccine formulations by Pfizer and Moderna (2 doses) and Johnson & Johnson (single dose) are calculated accordingly
- Each county is depicted by a colored circle, and the relative position of each corresponds to the proportion vaccinated. Actual numbers (count) are included in parenthesis.
- Data is described from **Dec 15**, **2020 Aug 23**, **2021**. All residents of the seven counties **aged 50-64** years are included.
- Overall, 56.9% of those aged 50-64 years in Two Rivers Health District are now fully vaccinated; 58.9% have received at least one dose of COVID vaccine.






- Vaccine formulations by Pfizer and Moderna (2 doses) and Johnson & Johnson (single dose) are calculated accordingly
- Each county is depicted by a colored circle, and the relative position of each corresponds to the proportion vaccinated. Actual numbers (count) are included in parenthesis.
- Data is described from Dec 15, 2020 Aug 23, 2021. All residents of the seven counties aged 65 years and over are included.
- Overall, 82.7% of those aged 65+ years in Two Rivers Health District are now fully vaccinated; 84% have received at least one dose of COVID vaccine.





- The graph below describes the number of **persons fully vaccinated daily in each of the 7 counties** in TRPHD..
- The line describes the **cumulative number of fully vaccinated residents** in TRPHD over time **(4 Jan 23 Aug)**.
- Thus, (for eg) "on 23 Aug, 41% of TRPHD residents were fully vaccinated".





• As of Aug 23, 2021, 41% of TRPHD's entire population has been fully vaccinated. Details of **vaccination rates by age** in each of the seven counties in Two Rivers Health District is shown. The legend for color codes used is displayed below. Percentages have been rounded off to the nearest whole number.

APPENDIX 1

Background

The Two Rivers Public Health Department (TRPHD) covers 7 counties in central Nebraska, reaching 96,986 people who live and work in the health district spread across roughly 4663 square miles. Over three quarters of residents live in Buffalo and Dawson county, a tenth live in Phelps county, and the remaining 15% is spread somewhat comparably among the four counties of Kearney, Harlan, Franklin and Gosper in decreasing order of population. The largest cities are Holdrege (pop. 5408), Lexington (pop. 10115) and Kearney (pop. 33867) meaning that well over half the residents of TRPHD live in three cities, and over a third are in Kearney alone. The population of all 7 counties in TRPHD are shown below.

Vaccine-eligible population

The total COVID-19 vaccine-eligible population of Two Rivers Health District is currently about 81,216. This includes all residents over the age of 12 years living in the seven counties that make up the district. The table below describes the eligible population in each of the seven counties divided by age category.
